- cases that are the subject of a suppression order

The search report will include the following information:

- case and proceeding number (eg 2009/00001234 001 or 2009/00001234 002)
- case title (eg Jane Citizen v ABC Company)
- future listing dates (if applicable)
- case type (eg Claim or Application under Corporations Law)
- case status (eg open or closed)
- lodgement date (the date the case was filed in the Court).

A fee is payable at the time you submit your application to the Registry.

Search criteria that identify less than 50 cases eligible for release will be emailed to you within 48 hours. If the requested search identifies more than 50 cases eligible for release, your results will be emailed to you within 5 business days. A staff member will contact you when more than 50 results are identified to give you an opportunity to refine your search and receive the results sooner e.g. limiting your search to cases commenced in the last year.
