Short Minutes of Order

The Court makes the following orders:

- 1 The time for WSP to serve its evidence on quantum be extended to 4 February 2022.
- 2 The time for Evolution to serve its evidence on liability be extended to 18 February 2022.
- 3 The time for Evolution to serve its evidence on quantum be extended to 4 March 2022.
- 4 Each of the parties Structural Engineering Experts (Structural Joint Meeting) to meet in the week commencing 14 March 2022 for the purposes of preparing a joint report.
- 5 Each of the parties Concrete Experts (Concrete Joint Meeting) to meet in the week commencing 14 March 2022 for the purposes of preparing a joint report.
- 6 The Structural Joint Meeting and the Concrete Joint Meeting be facilitated by a legal practitioner, experienced in construction litigation to be agreed by the parties.
- 7 The experts prepare a report of the Structural Joint Meeting and the Concrete Joint Meeting by 8 April 2022.
- 8 The costs of the facilitator for the Structural Joint Meeting and the Concrete Joint Meeting be initially shared equally by any party serving an expert report which addresses Structural Engineering or Concrete issues.

9 A joint meeting of the Quantity Surveying / Construction Cost Experts be held in the week commencing 28 March 2022.

10 The Quantity Surveying / Construction Cost Experts to prepare a joint report by 11 April 2022.

11 A joint meeting of the Valuation Experts be held in the week commencing 14 March 2022.

12 The Valuation Experts to prepare a joint report by 8 April 2022.

13 Each joint report prepared referred to in these orders is to set out areas of agreement and disagreement and the reasons for any disagreement.

14 The parties to agree to any specific questions to be addressed in the joint reports by 25 February 2022.

15 If there is any dispute as to the questions to be addressed in the joint reports, each party in dispute is to set out the questions that the party says should be addressed in one or more of the joint report(s) (Statement of Disputed Questions) and serve the Statement of Disputed Questions on each party to the proceedings by 2 March 2022.

16 The Proceedings be listed for determination of any Statement of Dispute Questions or any dispute about the identity of the facilitator of the joint meetings of the Structural Engineering Experts and the Concrete Experts on 4 March 2022.

17 The Proceedings are otherwise listed for directions on 4 March 2022.

18 Liberty to apply on three days' notice.
